2. Only valid entries submitted between Tuesday 16 January 2018 to Sunday 28 January 2018 at Perth Convention and Exhibition Centre (PCEC) are eligible.
3. Entry is open to all Australian residents 18 years or over who have a valid ticket to the WA Museum exhibition ***Dinosaur Discovery: lost creatures of the Cretaceous.***
4. Photo identification may be required upon collection of the prize.
5. One entry per person.
6. Employees (and their immediate families) of the WA Museum, PCEC and their related agencies and suppliers associated with this Competition are ineligible to enter.
7. To enter the Competition, eligible participants are required to attend the exhibition *Dinosaur Discovery: lost creatures of the Cretaceous* at PCEC, provide their details on the supplied format and place the printed entry form in the entry box at the admission counter at PCEC.
8. Ten prize winners will be drawn at 10am AWST on Monday 5 February 2018.
